Program overview

Blue Cross Blue Shield of Michigan and Blue Care Network contracted with Home & Community Care (formerly known as naviHealth, Inc.) to implement a nonclinical, transitional care program to help reduce avoidable inpatient readmissions.

This program is available to Medicare Plus BlueSM and BCN AdvantageSM members who are discharged from inpatient facilities to one of the following settings:

- Their homes either in Michigan or outside of Michigan
- Certain post-acute care facilities in Michigan. (See the list of participating facilities later in this document.)

How the program works

Home & Community Care staff support these members for up to 30 days after discharge from inpatient facilities.

With each interaction, Home & Community Care staff members introduce themselves to the member, using their name and licensure (if applicable) and the Home & Community Care name.

Timing	Details
Prior to discharge from an inpatient facility	<p>Home & Community Care navigation specialists work with each member to:</p> <ul style="list-style-type: none"> • Discuss their current health and whether he or she feels ready to be discharged. • Identify social determinants of health through naviHealth’s proprietary technology. • Address barriers to continuity of care. <p>The navigation specialists share this information with the naviHealth patient navigator who is assigned to the member for post-discharge care.</p>

Timing	Details
<p>After members leave inpatient facilities</p>	<p>Home & Community Care patient navigators work with each member to:</p> <ul style="list-style-type: none"> • Review their discharge needs. • Provide education to achieve better outcomes based on the discharge plan. • Create a plan to address any health barriers. • Assist in overcoming barriers that were identified prior to discharge. This may include scheduling appointments, coordinating care or connecting members to community resources to address social determinants of health. • Assist with medication adherence. <p>If the patient navigator has concerns about a member, he or she may reach out to the member's health care provider.</p> <p>Note: Patient navigators are commonly known as community health workers. These Home & Community Care staff members are trusted, knowledgeable frontline personnel who typically reside in or near the communities they serve.</p>
