Access tools and reference documents on our provider portal	 Log in to our provider portal (availity.com*). To check member information or status a claim, click Patient Registration or Claims & Payments on the menu bar. To find our provider applications, click Payer Spaces on the menu bar and then click the BCBSM and BCN logo. To find the Provider Resources website, click the Resources tab and then click Secure Provider Resources (Blue Cross and BCN). TIP: Within the Provider Resources website, this information is of particular interest to chiropractors: The Blue Cross Commercial Provider Manual has a Chiropractic Services chapter. Find it under Publications > Manuals > Blue Cross commercial > scroll down to Services – Physicians and Professionals. Helpful billing information is also available in the Billing and Claims section.
