Submitting appeals and peer-topeer review requests in e-referral for inpatient hospital admission denials

Inpatient hospital providers can now submit requests for appeals and peer-to-peer reviews when an admission has been denied. This process is similar to the referral portal submission process already in place for initial authorization requests. For hospitals that don't currently have the ability to submit appeals or peer-to-peer requests through e-referral, questionnaires will be available for any denial decisions made on or after April 1, 2024.
